Powers and Duties of 'Board of Studies' as per Ordinance No-7

To coordinate the teaching and research work in the Programmes assigned to the Department(s);

To appoint committees of courses for the Department(s), wherever

required, to supervise the work of such committees.

To recommend to the Board of School, the scheme courses and syllabi of Studies in the various programmes assigned to the Department(s).

To recommend to the Board of School, name of paper setters, examiners and moderators, wherever required;

To consider schemes for the advancement of the standards of teaching and research, and to submit such proposals to the Board of School concerned.

To consider schemes for interaction with industry and to submit such proposals to Board of School concerned.

To prepare and formulate schemes for School Development and to submit such proposals to Board of School concerned.

(viii) To consider feedback reports on the placement and employability of the passed out students and to suggest remedial measures, wherever necessary, for consideration of the Board of School concerned.

To consider proposals for revenue generation including professional consultancies, Resource sharing etc. and to submit such proposals to Board of School concerned.

To perform all other functions which may be prescribed by the (x) Ordinances / rules, and to consider all such matters as may be referred to it by the Board of School, the Academic Council or the Vice-Chancellor;

To delegate to the Chairman, or to any other member of the Board or to a Committee, such or specific powers as may be decided upon by the Board from time to time.

Terms of Membership

All members of the Board of Studies shall hold office for a term of two years. The term of members shall commence from [4.03.2025 to 18.03.2027. Any member can be considered for re-nomination.

Meetings

Notice for a meeting of the Board, shall ordinarily be issued at least 10 days before the day fixed for the meeting. However, an emergent meeting can (i) be called at a shorter notice, with the prior approval of the Vice- Chancellor.
